

Chung Cheng Financial and Economic Law Review Guidelines for Contributors

1. From 2011, Chung Cheng Financial and Economic Law Review publishes two issues per year (January and July respectively) in traditional Chinese.
2. Manuscripts regarding financial and economic law, civil and commercial law, case analyses, comments on practical issues, book reviews, and translated articles are all invited for submission. Manuscripts submitted will be reviewed on a first come first reviewed basis.
3. Manuscripts can be submitted in either Chinese or English, which shall not exceed twenty thousand words in principle. Every manuscript shall include the title of the manuscript in both Chinese and English, author's name, education, affiliation, table of content, approximately five keywords in both Chinese and English, as well as abstract in three hundred words in both Chinese and English. If the manuscript is submitted by an author abroad, only the English information should be attached.
4. Chung Cheng Financial and Economic Law Review reserves the right to modify the English title, table of content, text, keywords, and abstracts of a manuscript accepted for publication. If there are

more than one contributor, please state clearly the order of the contributors and each contributor's responsible part in the manuscript.

5. For the coordination of the style, the chapters and sections must be numbered in the following order: for manuscripts in Chinese: “壹、一、(一)、1、(1)、A、a.”. For manuscripts in English: “I. A. (A) 1. (1) a. (a)”.
6. Citations and references should follow Chung Cheng Financial and Economic Law Review Format of Notes, which can be found at the website of the Department of Financial and Economic Law. Manuscripts without footnotes, double submitting, non-conformity with the format specified by the Review, or the content of the manuscript was published or accepted in whole or in part by other journals, will be rejected for publication.
7. Manuscripts must be typewritten, in Microsoft Office (word) in principle and should be sent to the editorial board of Chung Cheng Financial and Economic Law Review (4F., College of Law, No.168, Sec. 1, University Rd., Min-hsiung, Chiayi County 621301, Taiwan R.O.C.); or directly e-mail to: felaw@ccu.edu.tw for double-blind peer review and editing.
8. Once a manuscript is published, it is deemed that the author has non-exclusively authorized the manuscript to be used by the Department of Financial and Economic Law for editing,

dissemination or public dictation as needed, and the full text of the manuscript will be publicly transmitted on the Internet after publication. It is the author's responsibility to ascertain the accuracy of all the factual materials in the manuscript. The Review will not provide any remuneration to the author. Ten off-prints and one copy of the current journal will be provided to the author in honor of the contribution.

9. The publication order of the accepted manuscripts in the Review is according to corporate law, international economic law, intellectual property law, tax law, and other fields.
10. Authors of the manuscripts accepted for publication must agree that the Department of Financial and Economic Law is entitled to delegate the National Library or other electronic databases the rights of reproducing, providing service through the internet, authorizing users to download, print, and browse, etc., and modifying the format in consistent with the databases' requirements.
